Ile Adaramola

Ile is an Asheville-based lawyer and nonprofit leader dedicated to developing community-powered solutions, with a passion for education as a fundamental right. In addition to serving as Board Chair for Read to Succeed Asheville/Buncombe, Ile serves on the board for Asheville City Schools Foundation and is an active member of The Links, Incorporated. After earning a Bachelor of Arts in Criminal Justice and Philosophy with high honors from the University of North Carolina at Charlotte, Ile attended North Carolina Central University School of Law on a full academic scholarship from the American Intellectual Property Law Education Foundation, earning her Juris Doctor with honors.



Tiffany Drummond Armstrong

Tiffany is in her 20th year of fundraising and nonprofit management, having served The Leukemia & Lymphoma Society, Pediatric Brain Tumor Foundation, and College Diabetes Network. She worked many years in event fundraising and has since been Executive Director, Vice President of National Campaigns, and Chief Development Officer.
